Mosquito Control Services

This agreement provides for services to control or mitigate infestations. Mosquito Shield of Mid Central NJ shall not be responsible for any injury, disease, or illness resulting from bites, infestation, or contamination, or for the repair of any damage caused by such pests.

Service Frequency: See Service Schedule Below.

Covered Pests: Mosquitos and/or Ticks

Service Schedule

Mosquito Customers: Every 10-17 days, on average, from start date.

Tick Customers: Tick treatments are applied roughly every 45-60 days.

Our Mosquito Treatment Season: Early-May through End-Sept. (weather permitting)

Our Tick Treatment Season: Mid-Apr. through End-Sept. (weather permitting)

Please be advised that severe weather conditions, such as downpours, high heat and/or strong wind conditions may cause us to reschedule your services to the next available date. You will receive an email and/or text message from us if we reschedule services.

Auto Pay / Late Payments

If the customer has provided payment card information, customer authorizes Mosquito Shield of Mid Central NJ to automatically debit customer's credit or debit card monthly for the service, including the initial service payment, recurring payments, and any other charges for additional services requested by the customer. This authorization shall remain in effect until notice of cancellation from the customer is received by Mosquito Shield of Mid Central NJ. **Late Payment Penalty.** Upon the failure of Buyer to pay in full any installment due hereunder within 14 days of the due date for such installment, a late payment penalty of \$20.00 Dollars shall immediately be charged to Buyer and Buyer shall pay the Late Payment Amount to Sellers within 14 days of the original due date of such installment.

Terms and Conditions - Treatments

Term. Seasonal

Mosquitoes. Our proprietary Mosquito Protection Blend is applied every 10-17 days; around all active areas such as decks, patios, pools, swing sets, etc. Our treatments are Guaranteed to reduce your mosquito population by 85-90%. Also, our proprietary Rain Shield is added for improved protection during wet weather conditions which allows the barrier to remain in effect.

All Natural Mosquito Treatments. We treat approximately every 14 days (weather dependent). We are unable to re-spray all natural customers as there is no controlled insecticide being applied. You may opt to switch to our regular treatment at anytime without an increase in price.

Ticks. Our Tick Treatment will reduce and kill the adult tick population as well as reduce in the infant (larva) stage. Two, three or four applications are included per season which is performed during your scheduled mosquito service. (dependent on your start date).

All Natural Tick Treatments. Two, three or four applications are included per season which is performed during your scheduled mosquito service (dependent on your start date). We are unable to re-spray all natural tick customers as there is no controlled insecticide being applied. You may opt to switch to our regular treatment at anytime without an increase in price.

Terms and Conditions - Property Upkeep & Maintenance

The perimeter - of your property should be free and clear of debris (leaves, woodpiles, brush, dog waste, etc). These are ideal places for mosquitoes to lay their eggs and breed. Please remove them in order for our products to be effective, so we can achieve optimal results throughout the season.

Lawn Care - Regular and periodic mowing of the lawn can help reduce the number of pests. You should cut your grass before we spray for mosquitoes/ticks because it helps a majority of the insecticide to get to the stems where the insects are hiding.

Our ReSpray Policy

Obviously, no one can guarantee 100% control of any flying insect, but we try! You should notice a dramatic reduction in the mosquito population with the first treatment, then it should get better and better with each subsequent treatment, as we get through that lifecycle of the larvae on your property. As mosquitoes hatch, they will unfortunately fly around and may even bite, but once they land on treated vegetation, they will die. If you do have a breakthrough, we will come out within 3 days dependent upon weather conditions to respray your property at no charge. Please allow 24-48 hours for the product to reach its full potential after every application.

Notification Sign

NJ Pesticide Notification Sign Law. NJ law requires us to post a sign around the treated property at the start of the application and for at least 24 hours following the application or longer if required according to re-entry precautions given on the pesticide product label. Please do not remove until 24 hours.

Help Us Improve The Results of Our Service

Best Practices to help minimize mosquito breeding areas.

- Empty standing water from buckets, kiddie pools, tires, etc.
- Check planter drip trays, corrugated downspout pipes and gutters for clogs and standing water.
- Cover waste containers to keep out rainwater or drill holes in the bottom to allow water to run through.
- Clean and refill bird baths every few days.
